THE WILD BIRDS PROTECTION (COUNTY OF FORFAR) ORDER, 1912..

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1889 to 1904, and upon application by the County Council of the County of Forfar, I, the Right Honourable Thomas McKinnon Wood, His Majesty's Secretary for Scotland, do hereby make the following Order:

- 1. The whole of the County of Forfar is hereby exempted from the operation of the Act of 1880, as to the undermentioned birds:—All Gulls, Cormorant, Goosander.
- 2. This Order shall come into force on the first day of January, 1913, and shall be published in the London Gazette and in the Edinburgh Gazette.
- 3. This Order may be cited as The Wild Birds Protection (County of Forfar) Order, 1912.
