The Joint Committee of the several bodies of Commissioners appointed for the purposes of Part I of the National Insurance Act, 1911, and the Insurance Commissioners constituted under the said Act, acting jointly, hereby give notice that, pursuant to the provisions of the National Health Insurance (Special Orders Acceleration) Order (No. 2), 1912, they have made a Provisional Special Order in the terms of the draft Special Order under sub-section (7) of section 47 of the said Act (of which notice has already been published)—

(a) extending the provisions of the said section 47 as respects the following, viz:—
F. Gustav Ernst, of 80 and 82, Charlotte Street, Fitzroy Square, London, W.; S. Maw, Son and Sons, of 7 to 12, Aldersgate Street, London, E.C.; the Earlestown Industrial Co-operative Society Limited, of Earle Street, Earlestown, Lancashire; the Newcastle-upon-Tyne Co-operative Society Limited, 103, Newgate Street, Newcastle-upon-Tyne, Northumberland; and the Rother Vale Collieries Limited, of Treeton, near Rotherham, Yorkshire; to employments of any class (not being a class of employment specified in any Special Order made under sub-section (1) of the said section 47), by or under any of the said employers, if by the terms of the employment the person employed is entitled to not less than one week's notice of the termination of his employment, and

(b) containing provisions for the purpose of adapting the other provisions of Part I of the said Act to the classes of employment to which the provisions of section 47 of the

Act are so extended.

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 20TH DECEMBER 1912.)

KENT (FOOT-AND-MOUTH DISEASE) ÖRDER OF 1912 (No. 6).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Modification of Existing Orders.

1. The Kent (Foot-and-Mouth Disease) Order of 1912 and the Kent (Foot-and-Mouth Disease) Orders of 1912 (Nos. 3, 4, and 5), all of which Orders are hereinafter referred to as "the existing Orders," are modified in manner hereinafter appearing.

Alteration of Zones I and II, and the Prohibited Parts of Zone I.

2. The existing Orders shall be read and have effect as if the Zone I, the Prohibited Parts of Zone I, and the Zone II, described in the Schedule hereto, were respectively substituted for the Zone I, the Prohibited Parts of Zone I, and the Zone II, to which the existing Orders refer, and the Scheduled District for the purposes of those Orders shall comprise only the Zone I, the Prohibited Parts of Zone I, and the Zone II, as described in the Schedule hereto.

Commencement,

3. This Order shall come into operation on the twenty-third day of December, nineteen hundred and twelve.

Short Title, &c.

4. This Order may be cited as the Kent (FOOT-AND-MOUTH DISEASE) ORDER OF 1912 (No. 6), and shall be read with the existing Orders.

SCHEDULE.

Zone I.

The Area described as the Prohibited Parts of Zone I in the Schedule to the Kent (Footand-Mouth Disease) Order of 1912 (No. 5), but excluding the Prohibited Parts hereinafter described.

Prohibited Parts of Zone I.

Any Foot-and-Mouth Disease Infected Place and any premises to which a Notice (Form D) given under Article 6 of the Foot-and-Mouth Disease Order of 1895 applies.

Zone II.

The Zone described as Zone I in the Schedule to the Kent (Foot-and-Mouth Disease) Order of 1912 (No. 5), but excluding therefrom Zone I and the Prohibited parts of Zone I as described in this Schedule.
