The limits of the Swine-Fever Infected Area declared by Order of the Board dated the twenty-second day of October, nineteen hundred and twelve, are hereby extended so as to comprise the Area described in the Schedule to this Order, and the Area so described is hereby declared to be a Swine-Fever Infected Area for the purposes of the Swine-Fever (Regulation of Movement) Order of 1908.

Commencement.

2. This Order shall come into operation on the nineteenth day of January, nineteen hundred and thirteen.
