WILD BIRD (ENGLAND).

The Wild Birds Protection (Administrative County of Salop) Order, 1913.

Dated 31st March, 1913.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1908, and upon application by the Council of the Administrative County of Salop, I hereby make the following Order:—

Title.

I. This Order may be cited as "The Wild Birds Protection (Administrative County of Salop) Order, 1913."

BIRDS.

Additions to the Schedule of the Act of 1880.

II. The Wild Birds Protection Act, 1880, shall apply within the Administrative County of Salop to the following species of Wild birds in the same manner as if those species were included in the Schedule to the Act:—

Pied Flycatcher, Spotted Flycatcher, House Martin, Sand Martin, Nuthatch, Lesser Redpole, Mealy Redpole, Siskin, Swallow, Swift, Tree-creeper, Grey Wagtail, White Wagtail, Yellow Wagtail.

Certain Birds Protected during the whole of the Year.

III. During that period of the year to which the protection afforded by the Wild Birds Protection Act, 1880, does not extend, the killing or taking of the following species of Wild Birds is prohibited throughout the Administrative County of Salop:—

Goldfinch, Kingfisher, Owl (all species), Lesser Redpole, Mealy Redpole, Siskin, Woodpecker (all species).
