

EGGS.

Certain Eggs Protected throughout the County.

IV. The taking or destroying of the Eggs of the following species of Wild Birds is prohibited throughout the Administrative County of Salop:—

Crossbill, Curlew, Pied Flycatcher, Spotted Flycatcher, Goldfinch, Great Crested Grebe, Kingfisher, Nightingale, Nightjar, Nuthatch, Owl (all species), Shrike, Teal, Grey Wagtail, White Wagtail, Yellow Wagtail, Widgeon, Wild Duck, Woodpecker (all species), and (after April 15th in each year) Lapwing (Peewit or Green Plover).

Repeal of former Order.

V. The Order of the 23rd April, 1904, is hereby repealed.
