the Administrative County of West Suffolk, I hereby make the following Order:—

Title.

I. This Order may be cited as "The Wild Birds Protection (Administrative County of West Suffolk) Order, 1913."

BIRDS.

Additions to the Schedule of the Act of 1880.

II. The Wild Birds Protection Act, 1880, shall apply within the Administrative County of West Suffolk to the following species of Wild Birds in the same manner as if those species were included in the Schedule to the Act:—

Hedge Accentor (Hedge Sparrow), Reed Bunting, Great Bustard, Common Buzzard, Corn Crake (Land Rail), Tree Creeper, Crossbill, Turtle Dove, Spotted Flycatcher, Hen Harrier, Marsh Harrier, Montagu's Harrier, Hawfinch, Heron, Hobby, Kestrel, House Martin, Sand Martin, Nuthatch, Ring Ouzel, Meadow Pipit, Tree Pipit, Quail, Water Rail, Redpoll, Redstart, Robin, Red-backed Shrike, Swallow, Swift, Bearded Tit, Coal Tit, Longtailed Tit, Marsh Tit, Grey Wagtail, Pied Wagtail, White Wagtail, Yellow Wagtail, Blackcap Warbler, Garden Warbler, Grasshopper Warbler, Garden Warbler, Sedge Warbler, Whitethroat, Lesser Whitethroat, Golden Crested Wren, Wryneck (Cuckoo's Mate or Snake Bird).

Certain Birds protected during the whole of the Year.

III. During that period of the year to which the protection afforded by the Wild Birds Protection Act, 1880, does not extend, the killing or taking of the following species of Wild Birds is prohibited throughout the Administrative County of West Suffolk:—

Great Bustard, Goldfinch, Owl (all species), Kestrel, Kingfisher.

Certain Eggs protected throughout the Administrative County.

IV. The taking or destroying of the Eggs of the following species of Wild Birds is prohibited throughout the Administrative County of West Suffolk:—

Bittern, Reed Bunting, Great Bustard, Common Buzzard, Corn Crake (Land Rail), Tree Creeper, Crossbill, Stone Curlew (Thickknee, Norfolk Plover), Turtle Dove, Spotted Flycatcher, Gadwall, Goldfinch, Great Crested Grebe, Red Necked Grebe, Sclavonian Grebe, Eared Grebe, Little Grebe (Dabchick), Hen Harrier, Marsh Harrier, Montagu's Harrier, Hawfinch, Heron, Hobby, Kestrel, Kingfisher, House Martin, Sand Martin, Nightingale, Nightjar (Fern Owl, Goatsucker, Nighthawk), Nuthatch, Golden Oriole, Ring Ouzel, Barn Owl, Long-eared Owl, Short-eared Owl, Tawny Owl, Meadow Pipit, Tree Pipit, Quail, Water Rail, Redpoll, Redshank, Redstart, Redbacked Shrike, Common Snipe, Swallow, Swift, Teal, Bearded Tit, Coal Tit, Long-

tailed Tit, Marsh Tit, Grey Wagtail, Pied Wagtail, White Wagtail, Yellow Wagtail, Blackcap Warbler, Garden Warbler, Grasshopper Warbler, Reed Warbler, Sedge Warbler, Whitethroat, Lesser Whitethroat, Woodcock, Green Woodpecker, Great Spotted Woodpecker, Lesser Spotted Woodpecker, Golden Crested Wren, Wryneck (Cuckoo's Mate or Snake Bird).

Repeal of former Order.

V. The Order of the 18th December, 1900, is hereby repealed.

In pursuance of Section 1 of the Rules Publication Act, 1893, notice is hereby given that the Secretary of State for the Home Department proposes, at the expiration of 40 days from the publication of this notice, to make an Order under Section 59 of the Factory and Workshop Act, 1901, reseinding (1) so much of the Order of the 4th May, 1903, as relates to the night employment of young persons in factories engaged in the refining of loaf sugar, in mineral dressing floors in Cornwall, and in factories and workshops connected with lead and zinc mines, and (2) the following Orders extending the special exception by which a male young person may be employed during the night:—

- (a) the Order of 9th August, 1904, relating to the processes of pressing and reeling cordite and nitrating and moulding guncotton carried on in non-textile factories:
- (b) the Order of 18th February, 1905, relating to the process of continuous wire drawing carried on in non-textile factories:
- (c) the Order of 16th April, 1911, relating to the process of making artificial silk fibre carried on in non-textile factories:

subject in each case to a provision that any young person who was lawfully engaged in pursuance of any of the said Orders on the 29th April, 1913, may continue to be so employed as if the rescinding Order had not been made.
