MOTOR CAR ACT, 1903.

COUNTY OF MIDDLESEX.

Whereas by sub-section 1 of Section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the Local Authority of the area in which the limits or place are situate; a person shall not drive a motor car at a speed exceeding ten miles per hour:

Notice is hereby given, that the County Council of Middlesex have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section, putting the above-mentioned provisions of that sub-section in force within the limits comprising so much of Thames Street and Upper Sunbury Road, in the Urban District of Hampton as extends from a point opposite Garrick Villa to a point opposite the Grammar School:

Notice is hereby further given, that objections to the making of any such regulation may be sent in writing to the Local Government Board, at their offices in Whitehall, London, on or before the twenty-seventh day of June, 1913.

A copy of any such objection should be sent at the same time by the objector to the County Council, addressed to the Clerk to the County Council of Middlesex, 63, Victoria Street, S.W.
