**NATIONAL INSURANCE ACT, 1911.**

(1 & 2 George V, ch. 55.)

Notice is hereby given, pursuant to the provisions of section 113 of the National Insurance Act, 1911, and of the Ninth Schedule to the said Act, that the Joint Committee of the several bodies of Commissioners appointed for the purposes of Part I of the said Act, and the Insurance Commissioners, the Irish Insurance Commissioners, and the Welsh Insurance Commissioners constituted under the said Act, acting jointly, propose to make a Special Order under section 47 of the said Act:—

(a) Specifying the class of employment set out in the Schedule hereto as being a class of employment in which a custom or practice prevails according to which the persons employed receive full remuneration during periods of disease or disablement, or some part thereof; and

(b) containing provisions for the purpose of adapting the other provisions of Part I of the said Act to cases under section 47 of the Act.

A draft of the proposed Order may be obtained, free of cost, on application to the Office of the National Health Insurance Joint Committee, Buckingham Gate, London, S.W.

Objections to the draft Order, by or on behalf of any person affected by its provisions, must be sent in writing within 40 days from the date of this notice, addressed to the Clerk to the Joint Committee at the above address.

**SCHEDULE.**

Employment by or under a Co-operative Society, if, by the terms of the employment, the person employed is entitled to not less than one week's notice of the termination of his employment.
