Square, Lincoln's Inn, London, W.C., Clerk in Holy Orders, and of the Reverend George Seymour Hollings, of Saint John's Mission House, Oxford, Clerk in Holy Orders, the Trustees of the Society of Saint John the Evangelist, as the patrons of the vicarage of the said parish of Worksop, and with the consent of the Right Honourable Francis John Savile Foljambe, of Osberton Hall, Worksop, a Member of Your Majesty's Privy Council, as the patron of the vicarage of the said new parish of Saint John, Worksop (in testimony whereof they, the said consenting parties, have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Worksop and of the said new parish of Saint John, Worksop, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consoli-dated chapelry for the said church of Saint Anne, Worksop, situate as aforesaid, and that the same should be named 'the Consolidated Chapelry of Saint Anne, Worksop.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal Wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The consolidated chapelry of Saint Anne, Worksop, comprising:—

"All those contiguous portions of the parish of Worksop and of the new parish (sometime consolidated chapelry) of Saint John, Worksop, both in the county of Nottingham and in the diocese of Southwell, which, taken together, are bounded upon the south by the extraparochial place called or known as Welbeck Abbey, in the said county and diocese, upon the west by the parish of Whitwell, in the county of Derby and in the said diocese of Southwell, upon the north-west by the new parish of Saint Luke, Shireoaks, in the said county of Nottingham and in the said diocese of Southwell, and upon the remaining sides, that is to say, upon the north-east and upon the east by an imaginary line commencing at the point where the boundary which divides the said new parish of Saint Luke, Shireoaks, from the said new parish of Saint John, Worksop, crosses the middle of the line of the Great Central Railway, and extending thence southeastward along the middle of the said line of railway for a distance of sixty-six chains or thereabouts to the point opposite to the northern end of the fence forming the western boundary of the close numbered 557 upon the Ordnance Survey Map of the parish of Worksop, published in the year one thousand eight hundred and ninety-eight, on the scale of twenty-five inches to a mile, and also upon the map or plan annexed to this representation, and extending thence southward first to the said fence and then along such fence and along the fence forming the western boundary of the close Number 776 upon the said maps for a dis-

tance in all of seventeen chains or thereabouts to the point where the last-mentioned fence meets the northern side of Sandy Lane, and extending thence first southward to and then south-eastward along the middle of Sandy Lane for a distance of eight chains and a half or thereabouts to its junction with Crown Street, and extending thence southward along the middle of Crown Street for a distance of five chains and a half or thereabouts to its junction with John Street, and extending thence southeastward along the middle of John Street for a distance of fifteen chains and a half or thereabouts to its junction with Gladstone Street, and extending thence eastward along the middle of Gladstone Street for a distance of five chains and a half or thereabouts to its junction with Portland Street, and extending thence southward along the middle of Portland Street for a distance of eight chains or thereabouts to its junction with Dock Road, and extending thence eastward along the middle of Dock Road for a distance of six chains or thereabouts to its junction with the road on the western side of Victoria Square, and extending thence southward along the middle of such road for a distance of one chain and a quarter or thereabouts to its junction with the street called Bridge Place, and extending thence first south-westward and then southward along the middle of Bridge Place for a distance of twelve chains to its junction with Bridge Street, and extending thence southward along the middle of Bridge Street for a distance of twenty-one chains or thereabouts to its junction with Park Street, and extending thence southward along the middle of Park Street for a distance of fifteen chains and a half or thereabouts to its junction with the road called Sparken Hill, and extending thence southeastward along the middle of Sparken Hill for a distance of one mile and seventy-four chains or thereabouts to the boundary which divides the said parish of Worksop from the said extraparochial place called or known as Welbeck Abbey.''

And whereas the said representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Southwell.
