#### SCHEDULE.

*Areas to which the Order applies.*

Areas in the county of Inverness:—

(a) In the Outer Islands:—

1. An Area in the Islands of Benbecula, in the parish of South Uist, comprising the crofting Township grazings and grounds of Rhueval.

2. An Area in the parish of South Uist comprising the crofting Townships grazings and grounds of Carnan and Iochdar.

3. An Area comprising the parish of Barra.

(b) Skye:—

4. An Area in the parish of Duirinish comprising the Farms of Braebost, Borve, and Lynedale, and the crofting Townships grazings and grounds of Kildonan, Flashadder, and Edinbane.

5. An Area in the parish of Duirinish comprising the crofting Townships grazings and grounds of Kilmuir and Dunvegan.

6. An Area in the parish of Duirinish comprising the crofting Townships grazings and grounds of Roag, Glasphein, and Fasach.

7. An Area in the parish of Duirinish comprising the Farm of Greshornish.

8. An Area in the parish of Kilmuir comprising the crofting Townships grazings and grounds of South Duntulm and North Duntulm.

9. An Area in the parish of Portree comprising the crofting Townships grazings and grounds of Achnahaid, Upper and Lower Ollach, Gedintailor, Balmeanach, and Peinchoran.

10. An Area in the parish of Strath comprising the Farm of Swòrdale or Suardale, and the crofting Townships grazings and grounds of Harrapool and Scullamus, Upper

Breakish, Lower Breakish, Ashaig, and Heast.

#### ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 19TH JULY 1913.)

#### BLACK MOUNTAIN DISTRICT (SHEEP-DIPPING) AMENDMENT ORDER OF 1913.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

The Black Mountain District (Sheep-Dipping) Order of 1913 shall be modified in manner hereinafter appearing:—

(i.) The dipping prescribed by Article 1 of that Order may be carried out with the licence of an Inspector of the Local Authority on any premises specified in the licence, and not necessarily on lands to which that Article applies.

(ii.) A licence may be granted under Article 2 for the movement of sheep to premises specified in the licence for the purpose of being dipped on such premises in the manner prescribed by such Article, and in such case the restriction imposed by the Article on movement of undipped sheep shall not apply.

(iii.) A licence under these modifications may contain such conditions as to movement, detention, isolation and dipping as the Inspector may deem desirable, and if the owner or person in charge of the sheep to which the licence relates fails to comply with any such condition he shall, according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.
