Electric Lighting Orders Confirmation (No. 3) Act, 1897.

## DUDLEY CORPORATION ELECTRIC LIGHTING ORDER, 1897.

OTICE is hereby given, that the Mayor, Aldermen and Burgesses of the Borough of Dudley (hereinafter referred to as "the Corporation ") intend to transfer their powers, duties, liabilities and works authorised by and executed under the above Order to the Shropshire, Worcestershire and Staffordshire Electric Power Company (hereinafter referred to as "the Company"), whose principal office is situate at Electrical Federation Offices, Kingsway, in the County of London, by deed, to be approved by the Board of Trade under Section 59 of the above Order, in respect of the area comprised in the County Borough of Dudley, in consideration of the payment by the Company to the Corporation of the amount required to pay off the outstanding loan and certain other expenditure not at present provided for out of loans raised by the Corpora-tion in connection with the Order. The period for which the transfer is proposed to be made will extend from the date of the deed of transfer until the undertaking is repurchased by the Corporation upon the terms of Section 2 of the Electric Lighting Act, 1888.

Provision will be made in the deed of transfer with respect to the following, amongst other matters:--- 1. That the following sections of the Order shall not apply to the Company:---

Section 7 as to purchase and use of lands. Section 52 as to application of revenue. Section 53 as to application of capital moneys.

Section 54 so far as it relates to the authentication of any notice, order or document by the Corporation.

Section 59 relating to the transfer of powers, &c.

Section 68 incorporating section 265 of the Public Health Act, 1875.

2. Providing for the audit of the annual statement of accounts of the undertaking and for the submission to the Board of Trade and the Corporation of the statement when audited with the Auditor's report.

3. Fixing the charges for the supply of electricity for a period of three years.

4. Requiring the Company to serve notices and plans on the Corporation prior to breaking up or interfering with any street or public bridge.

5. Prohibiting the Company from placing electric lines and street boxes above ground, except with the consent of the Corporation, in addition to any other consent required by the Order.

6. Authorizing the Corporation to prescribe the hours during which the Company may have access to their street boxes.

7. Providing for the determination of the price to be paid for the supply of energy for public lighting purposes.

8. Requiring the Company to give security for expenses incurred by the Corporation in executing works under section 12 of the Order and section 16 of the Schedule to the Electric Lighting (Clauses) Act, 1889.

9. Requiring the Company to supply to the Corporation a copy of the statutory map of the area of supply and of all regulations made by the Board of Trade.

10. Prohibiting the Company from consenting to or concurring in the revocation of the Order without the approval in writing of the Corporation.

11. Providing for the sale of the undertaking by the Company and empowering the Corporation to purchase in case the Company fail to perform the obligations imposed upon them by the deed of transfer or as undertakers by the Order or by any regulations made by the Board of Trade under the Order.

12. Providing for any question arising upon the deed of transfer to be settled by an arbitrator to be appointed by the Board of Trade.

And notice is hereby given, that a copy of the draft deed of transfer, as it is proposed to be submitted to the Board of Trade for their approval, has been deposited for public inspection at the office of the Town Clerk of the Borough of Dudley, and printed copies of the said draft will be supplied at the price of sixpence for each copy to all persons applying for the same at the respective offices of the Town Clerk, Town Hall, Dudley, and of Sydney Morse, No. 1, Kingsway, London, W.C.
