The Board of Trade, by virtue of the power conferred upon them by Section 369 (2) of the Merchant Shipping Act, 1894, do order that sea fishing boats registered at the ports of Yarmouth (Norfolk) or Lowestoft engaged mainly, or for at least seven months in the year, as steam drifters shall be exempt, and are hereby exempted, from the requirements of Section 413 of the Merchant Shipping Act, 1894, if and when as trawlers they are engaged in trawling off or around the coasts of the United Kingdom between the 1st January and the 1st May, provided that they carry a skipper and second hand holding an authority or certificate issued by the Board of Trade entitling them to act as skipper or second hand respectively of liners or drifters.

This Order shall come into force on 1st January, 1914, and shall remain in force until 1st May, 1916.
