Notice is hereby given, pursuant to the provisions of Section 113 of the National Insurance Act, 1911, and of the Ninth Schedule to the said Act, that the National Health Insurance Joint Committee, acting jointly with the Insurance Commissioners and the Welsh Insurance Commissioners, propose to make a Special Order under Section 6 of the National Insurance Act, 1913, excluding from the operation of Part I of the First Schedule to the National Insurance Act, 1911, certain employments under local and public authorities as set out in the Schedule hereto.

- Employment as Chaplain or other minister of religion.

Employment as an unpaid officer of any local or other public authority.

Employment otherwise than as an officer or servant of a local or other public authority, not being an employment specified in Part I (a) (b) (c) or (d) of the First Schedule to the National Insurance Act, 1911.

##### NATIONAL HEALTH INSURANCE.

The National Health Insurance (Discharged Seamen, Marines and Soldiers) Order, 1913, dated 6th October, 1913, made by the Insurance Commissioners under Section 78 of the National Insurance Act, 1911 (1 & 2 Geo. 5, c. 55).

Whereas by Section 78 of the National Insurance Act, 1911 (in this Order called "the Act"), it is amongst other things provided that if any difficulty arises in respect of bringing into operation Part I. of the Act, the Insurance Commissioners, with the consent of the Treasury, may by Order do anything which appears to them necessary or expedient for
