"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the seventh and eighth years of Her late Majesty Queen Victoria, chapter ninety-four; of the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninetyfour; and of the Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four, have prepared and now humbly lay before Your Majesty in Council the following Scheme or Representation for altering the boundaries of the new parish of Saint John, Cowley, in the county of Oxford and in the diocese of Oxford.

"Whereas by the authority of an Order of Her said late Majesty in Council, bearing date the thirtieth day of July, in the year one thousand eight hundred and sixty-eight, and published in the London Gazette on the fourth day of the following month, certain portions of the parish of Cowley, of the parish of Saint Clement, Oxford, and of the parish of Iffley, all in the said county and diocese, were constituted a separate district for spiritual purposes, and such district was named 'The District of Saint John, Cowley.

"And whereas the said district of Saint John, Cowley, has become a new parish of the character contemplated by the Act of the sixth and seventh years of Her said late Majesty, chapter thirty-seven, by the Act of the nineteenth and twentieth years of Her said late Majesty, chapter one hundred and four, and by the above-mentioned Act of the thirty-

second and thirty-third years of Her said late Majesty, chapter ninety-four.

"Now therefore, with the consent of the Right Reverend Charles, Bishop of Oxford (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation, and without any assurance in the law other than such duly gazetted Order, the boundaries of the said new parish of Saint John, Cowley, shall be altered so that all the extra-parochial liberty known as The Precinct of the Hospital of Saint Bartholomew without Oxford, which liberty or precinct is delineated and set forth upon the map or plan hereunto annexed, and is thereon coloured pink, shall be annexed to and shall in future form part of the said new parish of Saint John, Cowley.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending or proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore-mentioned Acts or of any of them or of any other Act of Parliament."
