dary which divides the said new parish of the Holy Trinity, Claygate, from the said parish of Cobham, and extending thence first northward, then eastward, then north-eastward, then south-eastward, and then again northeastward along the last-mentioned boundary for a distance of seventy-seven chains or thereabouts to the point at the north-eastern corner of the wood called Great Oaks, where such boundary meets the boundary of the said new parish of Saint Paul, Hook."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Winchester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, duly prepared and laid before His Majesty in Council a Representation, bearing date the thirty-first day of July, in the year one thousand nine hundred and thirteen, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven, and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared and now humbly lay before Your Majesty in Council the following Representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Catherine, Gorseinon, situate within the parish of Llandilo Talybont, in the county of Glamorgan and in the diocese of Saint David's.

"Whereas at certain extremities of the said parish of Llandilo Talybont and of the parish of Llangyfelach, in the said county and diocese, which said extremities lie contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such parishes.

the several churches of such parishes.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population afore—

parish of Loughor from the said parish of Llangyfelach at a point in the middle of the stream which flows across Mynydd Carn Goch and to the south of the houses called Spring

said) of the said parish of Llandilo Talybont and of the said parish of Llangyfelach, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Catherine, Gorseinon, situate as aforesaid.

"Now, therefore, with the consent of the Right Reverend John, Bishop of Saint David's, as such Bishop, and also as the patron in right of his See of the vicarage of the said parish of Llangyfelach, and as one of the patrons of the vicarage of the said parish of Llandilo Talybont, and with the consents of Joseph Edward Moore Gwyn, of Dyffryn, near Neath, in the said county of Glamorgan, Esquire, and Joseph Gwyn Moore Gwyn, of Dyffryn aforesaid, Esquire, as the remaining patrons of the said vicarage of the parish of Llandilo Talybont (in testimony whereof they, the said consenting parties, have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Llandilo Talybont and of the said parish of Llangyfelach, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Catherine, Gorseinon, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Catherine, Gorseinon.'

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The consolidated chapelry of Saint Catherine, Gorseinon, comprising:

- "1. All that portion of the parish of Llandilo Talybont, in the county of Glamorgan and in the diocese of Saint David's, which is comprised within and is co-extensive with the limits of the hamlet of Tyr-y-brenin, and is bounded upon all sides as follows, namely, upon the east partly by the parish of Llangy-felach and partly by the parish of Loughor, both in the said county and diocese, upon the south by the said parish of Loughor, upon the west partly by the new parish of Saint Michael and All Angels, Dafen, and partly by the parish of Llangennech, both in the county of Carmarthen and in the said diocese of Saint David's, upon the north-west by the said parish of Llangennech, and upon the north-east by the hamlets of Priscedwyn and Gwenlais, in the said parish of Llandilo Talybont.
- "2. And also all that portion of the said parish of Llangyfelach which is bounded upon the west by the above described portion of the said parish of Llandilo Talybont, upon the south by the said parish of Loughor, and upon the remaining side, that is to say, upon the north-east, by an imaginary line commencing upon the boundary which divides the said parish of Loughor from the said parish of Llangyfelach at a point in the middle of the stream which flows across Mynydd Carn Goch and to the south of the houses called Spring
