person to be his Deputy within any part of the Protectorate, during such temporary absence, and in that capacity to exercise, perform and execute for and on behalf of the Governor during such absence but no longer, all such powers and authorities vested in the Governor (except the power of pardon) as shall in and by such instrument be specified and limited, but no others.

Every such Deputy shall conform to and observe all such instructions as the Governor shall from time to time address to him for his guidance. Provided, nevertheless, that by the appointment of a Deputy as aforesaid the power and authority of the Governor shall not be abridged, altered, or in any way affected otherwise than His Majesty may at any time hereafter think proper to direct.

III. His Majesty, His heirs and successors, in Council may at any time revoke, alter, or amend this Order.

IV. This Order shall be published in the Uganda Government Gazette, and shall thereupon commence and come into operation.

And the Right Honourable Lewis Harcourt, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein.
