of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five; duly prepared and laid before His Majesty in Council a Representation, bearing date the eighteenth day of December, in the year one thousand nine hundred and thirteen, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven, and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council the following Representation as to the assignment of a consolidated chapelry to the consecrated church of All Saints, Goodmayes, situate within the parish of Barking, in the county of Essex and in the diocese of Saint Albans.

"Whereas at certain extremities of the said parish of Barking, of the new parish (sometime district chapelry) of Saint Mary, Great Ilford, of the new parish (sometime consolidated chapelry) of Saint Chad, Chadwell Heath, and of the parish of Dagenham, all in the said county and diocese, which said extremities lie contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such parishes and new parishes.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said parish of Barking, of the said new parish of Saint Mary, Great Ilford, of the said new parish of Saint Chad, Chadwell Heath, and of the said parish of Dagenham, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of All Saints, Goodmayes, situate as aforesaid.

"Now, therefore, with the consent of the Right Reverende Edgar, Bishop of Saint Albans, as such Bishop (in testimony whereof he has signed and sealed this Representation), with the consent of the Warden and College of the Souls of All Faithful People Deceased of Oxford, as the patrons of the vicarage of the said parish of Barking (in testimony whereof they have affixed their common or corporate seal to this Representation), with the consent of the Reverend Arthur Wyndham Ottaway, Vicar or Incumbent of the vicarage of the parish of Great Ilford, in the said county and diocese, as the patron of the vicarage of the said new parish of Saint Mary, Great Ilford, and also as the alternate patron of the vicarage of the said new parish of Saint Chad, Chadwell Heath (in testimony whereof he has signed and sealed this Representation), with the consent of the Reverend Clement Charles Harrison, Vicar or Incumbent of the vicarage of the said parish of Dagenham, as the other alternate patron of the said vicarage of the new parish of Saint Chad, Chadwell Heath (in testimony whereof he has signed and sealed this Representation), and with the consent of Stevenson Stewart Moore, of Douglas, in the Isle of Man, Barrister-at-Law, as the patron of the vicarage of the said parish of Dagenham (in testimony whereof he has signed and sealed this Representation), we, the said Ecclesiastical Commissioners for England, humbly represent that it would in our opinion be expedient that all those contiguous portions of the said parish of Barking, of the said new parish of Saint Mary, Great Ilford, of the said new parish of Saint Chad, Chadwell Heath, and of the said parish of Dagenham, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of All Saints, Goodmayes, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of All Saints, Goodmayes.'

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The consolidated chapelry of All Saints, Goodmayes, comprising:—

"All those contiguous portions of the parish of Barking, of the new parish (sometime district chapelry) of Saint Mary, Great Ilford, of the new parish (sometime consolidated chapelry) of Saint Chad, Chadwell Heath, and of the parish of Dagenham, all in the county of Essex, and in the diocese of Saint Albans, which are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the new parish of Saint John the Evangelist, Great Ilford, in the said county and diocese, from the said new parish of Saint Mary, Great Ilford, at the centre of Iron Bridge which carries Romford Road across the line of the Great Eastern Railway at the eastern end of Seven Kings Station, and extending thence north-eastward along the middle of the said line of railway (thereby following in part the last-mentioned boundary and crossing the boundary of the said new parish of Saint Chad, Chadwell Heath) for a distance of one mile and thirty-one chains or thereabouts to the boundary which divides the said new parish of Saint Chad, Chadwell Heath, from the said parish of Dagenham, and extending thence first south-westward and then southward along the last-mentioned boundary (thereby following in part the middle of Mayes Brook) for a distance of thirty-seven chains or thereabouts to the point where such boundary crosses the middle of Green Lane, and extending thence eastward along the middle of Green Lane for a distance of thirty-two chains or thereabouts to its junction with the roadway running past the eastern side of the premises attached to Valence Farm, and extending thence southward along the middle of such roadway and along the middle of the footpath in continuation thereof for a distance in all of fifty-two chains or thereabouts to the junction of the said footpath with Wood Lane, and extending thence westward along the middle of Wood Lane for a distance of thirteen chains. and a half or thereabouts to its junction with Gale Street and Longbridge Road upon the boundary which divides the said parish of
