THE PUBLIC HEALTH ACT, 1875.

URBAN DISTRICTS OF AMMANFORD AND CWMAMMAN AND PARISHES OF LLANDILO RURAL, LLANGUICK AND QUARTER BACH.

Proposed Formation of United District.

Whereas by section 279 of the Public Health Act, 1875, power is given to the Local Government Board to issue a Provisional Order to form any Urban or Rural Districts or any parts thereof into a United District for any of the purposes of the said Act:

And whereas application has been made to the Local Government Board to issue a Provisional Order forming the Urban Districts of Ammanford and Cwmamman, a part of the Rural District of Llandilo Fawr, viz., the Parishes of Llandilo Rural and Quarter Bach, and a part of the Rural District of Pontardawe, viz., the Parish of Llanguick, into a

United District for the purposes of the construction and maintenance of a main sewer or sewers and the disposal of sewage:

And whereas any such Provisional Order may provide for the constitution of a United District as aforesaid, or in such other manner as the Board may deem expedient, having regard to all the circumstances of the case, and of a Joint Board to act as the Governing Body of any United District, which may be constituted, and as to the powers, rights, duties, capacities, liabilities, and obligations of the Joint Board, and may also contain regulations as to such other matters and things as the case may require:

And whereas it is proposed that the Local Government Board should issue a Provisional Order to form the said Urban Districts of Ammanford and Cwmamman, and the said parts of the said Rural Districts of Llandilo Fawr and Pontardawe into a United District for the purposes aforesaid, and to make such provisions as aforesaid so far as the same shall be necessary:

Notice is hereby given, that R. G. Hetherington, Esquire, M.Inst.C.E., one of the Inspectors of the said Board, will attend at the Stepney Hall, Garnant, on Tuesday, the twenty-fourth day of February, 1914, at a quarter-past eleven o'clock in the forenoon, to hold a Local Inquiry into the subject-matter of the said application and the other matters aforesaid:

And notice is hereby further given, that any person interested may attend at such Inquiry, and be heard with reference to the said application and the other matters aforesaid.
