V. The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the County Borough of Stockport:---

Bittern, Dunlin, Great Crested Grebe, Little Grebe or Dabchick, Black-headed Gull, Hawfinch, Heron, Kestrel, Kingfisher, Nightjar (Fern Owl, Goat Sucker, Night Hawk), Owl, Oyster Catcher, Redshank, Sandpiper, Sheldrake, Shrike, Common Tern, Twite, Green Woodpecker, Great Spotted Woodpecker, Lesser Spotted Woodpecker, and (after May 1st in each year) Lapwing (Peewit or Green Plover).
