NATIONAL INSURANCE ACTS, 1911 то 1913.

Notice is hereby given, under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, acting jointly with the Insurance Commissioners, the Scottish Insurance Commissioners, the Irish Insurance Commissioners, and the Welsh Insurance Commissioners, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by the National Insurance Acts, 1911 to 1913, and by the National Insurance (Joint Committee) Regulations, 1912 and 1913, to make new regulations as to the Pay. ment and Collection of Contributions in respect of persons exempt from insurance, being Irish Migratory Labourers, and it is further proposed by such regulations to revoke the National Health Insurance [Collection of Contributions (Exempt Persons) (Irish Migratory Labourers)] Regulations (Ireland), 1912.
