"That the yearly sum of fifteen pounds shall be paid by equal half-yearly payments on the first day of January and the first day of July out of the annual value of the said vicarage of Caynham to the Incumbent of the benefice of Knowbury.

"That baptisms, churchings, marriages and burials arising out of the portion transferred shall henceforth be performed at the parish church of Knowbury, and that the fees, if any, for all such offices and all Ecclesiastical dues, offerings and other emoluments arising within the limits of the portion transferred, and usually payable to the Incumbent of a benefice shall belong to the Incumbent of the said district church of Knowbury.

"That the Incumbent of the said parish of Knowbury shall have exclusive cure of souls within the limits of the portion transferred.

"That the inhabitants of the portion transferred shall be exonerated from all liability to repair the parish church of Caynham, but shall become liable, in common with the inhabitants of the said parish of Knowbury, to the repairs of the district church of Knowbury. •

"CONSENTS.

"I, Charles Francis Kynaston Mainwaring, of Oteley Park, in the county of Salop, Esquire, the patron or the person entitled to present to the vicarage of Caynham, in the county of Salop and diocese of Hereford, in case the same were now vacant, and I, the Reverend Somers Percy Heriz-Smith, clerk, vicar of the said vicarage, do hereby respectively signify to Your Grace our consent to the scheme above proposed for separating the portion transferred from the parish of Caynham, and annexing same to the parish of Knowbury.

"I, the Right Honourable Herbert Henry Asquith, Prime Minister of Great Britain, and, on behalf of the Crown, the patron of the benefice of Knowbury, in the county of Salop and diocese of Hereford, and I, the Reverend George Russell Gipps, clerk, Incumbent of the said benefice, do hereby respectively signify to Your Grace our consent to the Scheme above proposed for transferring to the parish of Knowbury the portion transferred.

And whereas the said Scheme hath been transmitted by the said Bishop to the said Archbishop for his consideration.

And whereas the said Archbishop, being satisfied with the said Scheme, hath certified the same and the consents aforesaid to His Majesty in Council by his report, dated the 21st day of October, 1913, which said report is in the words and figures following:—

"We, the undersigned, Randall Thomas, Lord Archbishop of the province of Canterbury, do hereby represent to Your Majesty in Council.

"That the Right Reverend John Lord Bishop of Hereford has represented unto us (amongst other things).

"That there is in the county of Salop and his diocese of Hereford the vicarage of Caynham, the parish whereof comprises, amongst other places, part of the township of Bennett's End, the other part of the said township hav-

ing been transferred some time since by Order in Council to the consolidated district of St. Paul, Knowbury.

"That the part of the said township still remaining within the said parish of Caynham is situate at a distance of two and a quarter miles from the parish church of Caynham, and only one quarter to three quarters of a mile from the church of Saint Paul, Knowbury.

"That it appears to the said Lord Bishop that under the Acts of Parliament of the first and second years of Her late Majesty Queen Victoria, chapter 106, and the second and third years of Her said Majesty, chapter 49, such portion of the said township of Bennetts End still remaining in the parish of Caynham (more particularly described in the Scheme appended hereto and coloured pink in the plan annexed to such Scheme) may be advantageously separated from the said parish of Caynham and annexed to the parish of Knowbury, to which it is contiguous.

"That, pursuant to the directions contained in the twenty-sixth section of the said first-mentioned Act of Parliament, the said Lord Bishop has drawn up a Scheme in writing, describing the mode in which it appears to him that the proposed alteration may best be effected and how the changes consequent upon such alteration in respect of ecclesiastical jurisdiction, glebelands, tithe rentcharges, and other ecclesiastical dues, rates and payments, and in respect to patronage and rights to pews may be made with justice to all parties interested, which Scheme, together with the consents thereto, in writing, of Charles Francis Kynaston Mainwaring, the patron of the said vicarage of Caynham; the Reverend Somers Percy Heriz-Smith, vicar of the said vicarage; the Right Honourable Herbert Asquith, K.C., M.P., Prime Minister of Great Britain, on behalf of the Crown, the patron of the benefice of Knowbury; and the Reverend George Russell Gipps, Incumbent of the said benefice, has been transmitted to us for our consideration.

"The Representation and Scheme of the said Lord Bishop of Hereford and the consents above referred to are hereunto annexed.

"And we, the said Archbishop, being on full consideration and inquiry satisfied with the said Scheme, do hereby, pursuant to the said first mentioned Act of Parliament, certify the same and such consents as aforesaid to your Majesty in Council, to the intent that Your Majesty in Council may, in case Your Majesty in Council shall think fit so to do, make and issue an Order for carrying the said Scheme into effect.
