"And whereas we are of opinion that the Fleet or Staff Surgeon of the Royal Naval Training establishment for boys at Devonport, who has been entrusted with the medical supervision of the boys' and youths' training establishments generally at that port, should be granted charge pay on the foregoing scale, so long as he continues to perform such duties:

We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the grant of charge pay accordingly, with retrospective

effect as from the 1st January, 1914. "The Lords Commissioners of Commissioners of Majesty's Treasury have signified their concurrence in this proposal."

"And whereas we are of opinion that it is desirable to grant a Special Training Allowance in order to secure suitable Petty Officers, Leading Seamen, and Non-Commissioned Officers for these appointments, which involve responsibility for the control and supervision

of large numbers of young Boys:
"Now, therefore, we humbly submit that
Your Majesty may be graciously pleased by Your Order in Council to sanction the payment of the Training Allowances shown in the accompanying Schedule as a temporary arrangement for a period of three years.
"The Lords Commissioners of

Majesty's Treasury have signified their con-

currence in the foregoing proposals."

Per diem.

"To all Petty Officers and Non-Commissioned Officers who have, definite responsibility and charge of Boys out of instructional hours 6d. "To Leading Seamen employed in

the same capacity as above 341.

"These allowances not to be payable until the men concerned have completed a period of at least two months on probation and shown themselves fully capable of carrying out the

Training duties satisfactorily. 'The allowances then to be paid as from the date of completing the probationary period.

"The allowances not to be payable to Pensioners."
