

*Civil Service Commission,**April 17, 1914.*

The Civil Service Commissioners hereby give notice that an Open Competitive Examination for situations as Assistant Clerk (Abstractor Class) in Departments in the Civil Service will be held in London, Edinburgh, Dublin, Birmingham, Bristol, Cardiff, Leeds, Liverpool, Manchester, Newcastle-on-Tyne, Plymouth, Portsmouth and Glasgow, commencing on the 23rd July, 1914, under the Regulations dated the 1st April, 1910, and published in the London Gazette of the same date.

Whereas the Mayor, Aldermen, and Burgesses of the borough of Bury, being the Urban Sanitary Authority for the said borough, have made application to the Local Government Board for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, to partially repeal, alter, or amend the Bury Corporation Act, 1909, so as

(1) To repeal section 141 of the said local Act (which provides that no street shall be laid out for building purposes exceeding one hundred yards in length without at least one intersecting street in every one hundred yards thereof, except in the case of the site for any one building or works, with the outbuildings, yard, and approaches belonging thereto);

(2) For the several purposes of the application or for purposes connected with, incidental to, or consequent on those purposes, to make

any such alteration or amendment of the said local Act, or of any other local Act, or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, in force in the said borough as may be necessary or desirable;

And whereas it is proposed that a Provisional Order should be issued in compliance with the said application;

Notice is hereby given, that R. C. Maxwell, Esq., Barrister-at-Law, one of the Inspectors of the said Board, will attend at the Municipal Offices, Bank Street, Bury, on Thursday, the twenty-third day of April, 1914, at ten o'clock in the forenoon, to hold a local inquiry into the subject-matter of the said application and the proposed Provisional Order.

And notice is hereby further given, that any person interested may attend at such inquiry and be heard with reference to the said application and the proposed Provisional Order.

LLANDUDNO.

Whereas the Urban District Council for the Urban District of Llandudno (hereinafter called the Council) propose to purchase by agreement, under Section 20 of the Llandudno Urban District Council Act, 1897, a piece of land situate at Measdu in the district, and comprising an area of 132½ acres or thereabouts, and to set apart and lay out and improve such land, or a part thereof, for the purpose of the playing of golf, and have made application to the Local Government Board for sanction to borrow under the said Local Act a sum of £14,490 for the purchase of the said land;

And whereas the Council have also made application to the Local Government Board for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, to partially repeal, alter, or amend the said Llandudno Urban District Council Act, 1897, so as

1. To empower the Council to make charges for the use of the golf course proposed to be laid out on the said land; to permit the use thereof by any club or other body subject to such charges and conditions as they may think fit; and to let on lease or otherwise to any club, company, body or persons any portion of the said land;

2. To except from application to the said land the provision in subsection (1) of section 20 of the said local Act which requires that lands set apart thereunder for games shall be open to the public when not in use for such games;

3. To amend subsection (2) of the said section 20 so as to enable the Council to make
