WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five; duly prepared and laid before His Majesty in Council a representation, bearing date the twenty-third day of April, in the year one thousand nine hundred and fourteen, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five; have prepared, and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of All Saints, Chatham, situate within the new parish (sometime district chapelry) of Luton, in the county of Kent and in the diocese of Rochester.

"Whereas at certain extremities of the said new parish of Luton and of the new parish (sometime consolidated chapelry) of Saint Paul, Chatham, in the said county and diocese, which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such new parishes.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said new parish of Luton and of the said new parish of Saint Paul, Chatham, should be formed into a consolidated chapelry
