The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of His Majesty's Treasury, viz. —

SPECIAL REGULATIONS respecting an Open Competitive Examination for Situations as Assistant Clerks (Abstractor Class) in the National Health Insurance Commission, Wales.

(Supplementary to the General Regulations respecting Open Competitive Examinations for Situations in the Civil Service, included in Schedule A of the Order in Council of 10th January, 1910.)

I. The limits of age for this Examination are 17 and 18, and Candidates must be of the prescribed age on the 1st July, 1914.

II. The subjects of examination will be —

1. English.
2. A language: Latin, French, German or Welsh.
3. Elementary Mathematics.
4. A second language: Latin, French, German or Welsh
5. History and Geography.
6. Further Mathematics.
7. Science.

Of the subjects numbered 4 to 7, not more than two may be offered. In these subjects a high standard of performance will be required before any marks are assigned, so that a candidate may be free to offer them or to leave them, and may have a real chance of success on three subjects alone, or on four, as well as on five.

Candidates must obtain such an aggregate of marks in the Examination as a whole as to satisfy the Civil Service Commissioners

III. Application for permission to attend the Examination must be made at such time and in such manner as the Commissioners may appoint.

IV. A fee of 10s. will be required from every Candidate attending the Examination.
