

lawful for His Majesty, by and with the advice of His Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to His Majesty, with such advice as aforesaid, may seem fit:

And whereas by an Order in Council dated the 11th day of January, 1900, it was ordered that burials should be discontinued in (amongst other places) the parish church of Llanfihangel, in the county of Montgomery, and also in so much of the churchyard as is not situated (a) within fifteen yards of the west, south, and east boundaries thereof; or (b) to the north side of the church, with certain exceptions in the said Order in Council specified:

And whereas the Local Government Board, after giving to the Incumbent and the Churchwardens of the said parish of Llanfihangel ten days' previous notice of their intention in that behalf, have made a representation that, for reasons of public health, so much of the said Order in Council of the 11th day of January, 1900, as relates to burials in the parish church and the churchyard of Llanfihangel aforesaid, should be varied so as to provide that burials should be discontinued forthwith and entirely in the said churchyard: Provided that in the said churchyard the burial may be allowed of the bodies of Ann Griffith and D. C. Davies, for whom grave spaces have been reserved and appropriated as a burial place, with the exclusive right of burial therein, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave:

Now, therefore, His Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Privy Council, on the 30th day of July next.

And His Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parish affected by such representation one month before the said 30th day of July.

The following STATUTES made by the Governing Body of Merton College, Oxford, on the 7th day of May, 1914, and sealed on the 14th day of May, 1914, have been submitted for the approval of His Majesty in Council, and notice of their having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877."

The Warden and Fellows of Merton College, Oxford, respectfully submit for the approval

of His Majesty the King in Council the following amending Statutes which were duly made in accordance with the provisions of the Universities of Oxford and Cambridge Act, 1877, section 54, having been passed unanimously at a General Meeting of the Governing Body of the said College, specially summoned for the purpose, and held on the 7th day of May, 1914.

It was resolved at the said General Meeting

I. That the words "clear of Income Tax" be inserted

(i) in Stat. II. 4 (a), after "1500*l.* a year";

(ii) in Stat. III. II (a) (i), after "700*l.* a year";

(iii) in Stat. III. II (a) (ii), after "700*l.* a year";

(iv) in Stat. V. 3 (b), as amended in 1906, after "the annual stipend of one hundred pounds";

(v) in Stat. V. 6 (a), after "nor more than 300*l.*";

(vi) in Stat. V. 6 (d), after "200*l.* per annum";

(vii) in Stat. V. 7 (b), after "an annual stipend of 50*l.*";

(viii) in Stat. V. 7 (c), after "not less than 100*l.*";

(ix) in Stat. IX. (b), after "the further annual sum of 500*l.*";

(x) in Stat. XIII. 8, after "300*l.* per annum."

II. That a new sentence "Such allowances shall be clear of Income Tax" be added at the end of Stat. III. 15 (a).

III. That the words "rent free" in Stat. III. 15 (b) be deleted, and that the words "free of rent, rates and taxes" take their place.
