Employment as a porter, messenger, commissionaire or watchman in a club, hotel, office, shop, or other place in which a trade or business is carried on.
Employment as usher or messenger of a County Court.
Employment by or under a Co-operative Society.

Employment as a farm servant under a contract of not less than one year's duration (male unmarried persons only).

Note.

For the purposes of this Schedule-

- (a) the expression "warehouseman" shall be deemed to include a porter or packer employed in a uarehouse, and the expression "domestic servant" shall be deemed to include a menial servant employed in whole time service in or about a private residence.
- (b) employment by or under any one of the bodies (including a combination of local authorities) specified in this Schedule shall be deemed to be a separate employment and shall not include employment by or under any other body (including a combination of local authorities) or in any institution specified in this Schedule.

NATIONAL INSURANCE ACT, 1911.

(1 & 2 Geo. V, c. 55.)

The National Health Insurance Joint Committee and the Welsh Insurance Commissioners, acting jointly, hereby give notice, pursuant to the provisions of Section 113 of, and the Ninth Schedule to, the National Insurance Act, 1911, that for the purpose of consolidating and amending the provisions of certain Special Orders made under paragraph (i) of Part II of the First Schedule to the said Act (being Orders specifying classes of employment as being of such a nature that they are ordinarily adopted as subsidiary employment only, and not as the principal means of livelihood), so far as those Orders relate to Wales, they propose to make a Special Order under the said paragraph—

(a) specifying the classes of employment

mentioned in the First Schedule hereto as being of such a nature as aforesaid; and

(b) revoking the several Orders mentioned in the Third Schedule hereto in so far as those Orders were made under the said paragraph, and relate to Wales, so, however, that such revocation shall not affect any right, privilege, obligation or liability acquired, accrued or incurred under any of those Orders.

And the said Joint Committee hereby give further notice that they propose, with the approval of the Treasury, to make a Special Order under sub-section (2) of Section 1 of the said Act—

(a) providing that persons engaged in the classes of employment mentioned in the Second Schedule hereto shall be included amongst the persons employed within the meaning of Part I of the said Act, if they

If by the terms of the employment the person employed is entitled to not less than one week's notice of the termination of his employment.
