(b) revoking, so far as relates to Wales and subject to such reservation as aforesaid, such part of any of the Orders mentioned in the Third Schedule hereto as was made under sub-section (2) of Section 1 aforesaid.

A draft of the proposed Orders may be ob-

tained free of cost on application to the Office of the National Health Insurance Commission (Wales), City Hall, Cardiff.

Objections to the Draft Orders by or on behalf of any person affected by their provisions must be sent in writing within twenty-one days from the date of this notice, addressed to the Secretary to the Welsh Insurance Commissioners at the above address.

FIRST SCHEDULE.

Classes of employment specified as being of a subsidiary nature only and, therefore, excluded from being employment within the meaning of Part I. of the Principal Act.

(Note.—Persons engaged in any of the classes of employment which are marked in this Schedule with an asterisk are, when engaged under the conditions mentioned in the Second Schedule, included amongst the persons employed within the meaning of Part I. of the Principal Act).

Employment in connexion with Religious Worship, &c.

Employment, involving part-time service only, in or about a cathedral, church, or other place of religious worship in any of the following capacities:—

- (a) Civilian butt-marker or look-out man at rifle ranges used by members of the Territorial Force.
- (b) Temporary drill instructor in the Territorial Force.

Employment under Local Authorities, &c.

Employment involving part-time service only, by any local or other public authority, as a person employed to act in relief of gymnasium, lavatory, or playground attendants, or park constables.
