## Civil Service Commission, July 17, 1914.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the consent of the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS respecting Open Competitive Examinations for the Situation of Female Learner in London in the Department of the Postmaster-General.

These Regulations are liable to alteration from time to time.

1. The limits of age for this situation are 14 and 17. If an examination begins in one of the first four months of any year, Candidates must be of the prescribed age on the first day of January in that year. If an examination begins in one of the second four months of any year, Candidates must be of the prescribed age on the first day of May in that year. If an examination begins in one of the last four months of any year, Candidates must be of the prescribed age on the first day of September of that year.

[The limits of age for Candidates at Open Competitive Examinations held after the 1st April, 1915, will be 14 and 16.]

- 2. Candidates will be required to satisfy the Civil Service Commissioners.
  - (a) That they are unmarried or widows.
