MOTOR CAR ACT, 1903.

COUNTY OF LONDON.

Whereas by sub-section 1 of section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

Notice is hereby given, that the London County Council have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section, putting the above mentioned provisions of that sub-section in force within the limits comprising the following roads or parts of roads at Streatham, that is to say—

Streatham Common, North Side (otherwise known as Streatham Common North), extending from its junction with Streatham High Road to the County Boundary at the west end of Crown Lane; and

Streatham Common, South Side (otherwise known as Streatham Common South), extending from its junction with Streatham High Road to its junction with Streatham Common, North Side.

Notice is hereby further given, that objections to the making of any such regulation may be sent in writing to the Local Government Board, at their offices at Whitehall, London, on or before the seventeenth day of August, 1914.

A copy of any such objection should be sent
