The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:---

Landing of Animals for Slaughter within Landing Places at Avonmouth Dock (Bristol), Cardiff, and Deptford.

1. The Animals (Landing from Ireland) Amendment Order of 1914 (No. 20) shall be read and have effect as if the Irish Animals Landing Places at Avonmouth Dock (Bristol), Cardiff, and Deptford were included in the Second Schedule to that Order.

Special Provision as to Animals Destined for Deptford Landing Place.

2. A vessel conveying animals intended to be landed at the Deptford Landing Place shall not, whilst any of such animals are on board, enter any port in Great Britain other than the Port of London.

Short Title.

3. This Order may be cited as the ANIMALS (LANDING FROM IRELAND) AMENDMENT ORDER OF 1914 (No. 21).
