of Surrey for the issue of a Regulation in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising part of the road through the village of Woodmansterne, within the county of Surrey:

NOW THEREFORE, in pursuance of the powers given to Us in that behalf, We do, by this Our Order, make the following Regulations:—

ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising so much of the road through the village of Woodmansterne as

extends from a point opposite Weston Acres Lodge to the Rectory Gates.

ARTICLE II.—These Regulations shall come into operation on the twenty-fourth day of August, one thousand nine hundred and fourteen.
