Parish for ecclesiastical purposes, by the name of the Perpetual Curacy and Benefice of Sedgehill; and the Chapel at Sedgehill shall be the Church of the said separate Parish and Benefice.

"3. That all fees and other ecclesiastical dues and payments for marriages, burials, churchings, and other ecclesiastical offices, and all such other ecclesiastical dues, offerings, and emoluments usually payable to the Incumbent of a Parish or Benefice which shall arise or be payable for or in respect of the said Chapelry of Sedgehill, shall belong and be payable to the said Incumbent of the separate Parish of Sedgehill.

"4. That all the income now belonging or payable to the Incumbent of Berwick St. Leonard with Sedgehill arising from or belonging to the said Chapelry of Sedgehill shall belong to and shall be vested in and payable to and received by the Incumbent of the separate Parish or Benefice of Sedgehill.

"5. That all fees and other ecclesiastical dues and payments for marriages, burials, churchings, and other ecclesiastical offices, and all such other ecclesiastical dues, offerings, and emoluments usually payable to the Incumbent of a Parish or Benefice which shall arise or be payable for or in respect of the said separated portion of the said Parish of East Knoyle that shall be annexed to the said Chapelry of Sedgehill, shall belong and be payable to the Incumbent of the said separate Parish or Benefice of Sedgehill.

"6. That all that portion of the tithe rent charge belonging to the said Benefice of East Knoyle, and arising from the said separated portion of the Parish of East Knoyle, particulars whereof are set out in the said First Schedule hereto, and also all that portion of the tithe rent charge belonging to the said Benefice of East Knoyle, and arising from the parcels of land particulars whereof are set out in the Second Schedule hereto, shall be annexed to the said separate Parish or Benefice of Sedgehill, and belong to the Incumbent thereof.

"7. That two Churchwardens shall be

annually chosen in and for the said Parish or Benefice of Sedgehill, and every person so chosen shall be duly admitted and shall do all things pertaining to the office of Churchwarden as to ecclesiastical matters within the said separate Parish and Benefice.

"8. That the residence house at Sedgehill shall belong to and be the house of residence for the Incumbent for the time being of the said separate Parish and Benefice of Sedgehill.

"9. That no other alterations shall be made in respect of the tithe rent charges and other endowments of any of the said Benefices.

"10. That the patronage of the said separate Parish or Benefice of Sedgehill when annexed to the said portion of East Knoyle shall be vested in Lady Octavia Shaw Stewart as fully and beneficially as the patronage of the Benefice of Berwick St. Leonard with Sedgehill.

"11. That the inhabitants of Sedgehill shall henceforth cease to be entitled to accommodation in the Parish Church of Berwick St. Leonard, and shall be entitled to accommodation in the Parish Church of Sedgehill, except nevertheless such person or persons (if any) as may possess a legal right, by faculty or otherwise, to the exclusive use of any pews or sittings in the said Parish Church of Berwick St. Leonard and may not be willing to relinquish or give up the same. "12. That the inhabitants of the separated

"12. That the inhabitants of the separated portion of the said Parish of East Knoyle shall henceforth cease to be entitled to accommodation in the Parish Church of East Knoyle, and shall be entitled to accommodation in the Parish Church of Sedgehill, except nevertheless such person or persons (if any) as may possess a legal right, by faculty or otherwise, to the exclusive use of any pews or sittings in the said Parish Church of East Knoyle and may not be willing to relinquish or give up the same.
