

At the Court at *Buckingham Palace*, the 17th day of *September*, 1914.

PRESENT,

The KING's Most Excellent Majesty in Council.

**W**HEREAS the Local Government Board, after giving to the Incumbent and the Churchwardens of the Parish of West Tarring, in the Civil Parish of Worthing, in the County of West Sussex, and to the Incumbent and the Churchwardens of the Parish of St. Paul, Cullercoats, in the Civil Parish of Whitley and Monkseaton, in the County of Northumberland, ten days' previous notice of their intention in that behalf, have, under the provisions of the Burial Act, 1853, made Representations to His Majesty in Council, stating that, for the protection of the public health, the opening of any new burial ground in the Civil Parishes of Worthing, and Whitley and Monkseaton, aforesaid, save with the previous approval of the Local Government Board, should be prohibited, and that burials should be discontinued therein, as follows, viz. :—

**WORTHING.**—Forthwith and entirely in the Parish Church of Saint Andrew, West Tarring, in the Civil Parish of Worthing, in the County of West Sussex; and in the Churchyard, with the following exceptions, that is to say :—

(a) In any vault or walled grave now existing in the said Churchyard burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented.

(b) In any earthen grave now existing in the said Churchyard the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

(c) In the said Churchyard in grave spaces in which no interment has heretofore taken place, the burial may be allowed of the bodies of Charles Botting, Elizabeth Botting, Jesse Clupper, Sarah Ann Clupper, Fanny Clupper, Luke Clupper, Charlotte Foster, Joseph Gardner, Mary Gardner, John Kentish Harvey, Rebekah Harvey, George Goldring, Ruth Goldring, James Long, Jane Long, George Lord, William Marsh, Harriet Marsh, Edwin Potten, James Sayers and Alan Tyrrell, at their decease, subject to the condition that no part of the coffins containing the bodies shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

**WHITLEY AND MONKSEATON.**—Forthwith and entirely in the Parish Church of St. Paul, Cullercoats, in the Civil Parish of Whitley and Monkseaton, in the County of Northumberland; and in the Churchyard, with the following exceptions, that is to say :—

(a) In any vault or walled grave now existing in the said Churchyard burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented.

(b) In any earthen grave now existing in the said Churchyard the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

Now, therefore, His Majesty in Council is pleased hereby to give notice of such Representations, and to order that the same be taken into consideration by a Committee of the Privy Council, on the 29th day of October next.

And His Majesty is further pleased to direct that this Order be forthwith published in the *London Gazette*, and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parishes affected by such Representations one month before the said 29th day of October.

**W**HEREAS the Local Government Board, after giving to the Incumbent and the Churchwardens of the Parish of Llanferras, in the County of Denbigh, ten days' previous notice of their intention in that behalf, have, under the provisions of the Burial Act, 1853, made a Representation to His Majesty in Council, to the effect that, for the protection of the public health, the opening of any new burial ground in the Civil Parish of Llanferras aforesaid, save with the previous approval of the Local Government Board, should be prohibited, and that burials should be discontinued therein, as follows, viz. :—

**LLANFERRAS.**—Forthwith and entirely in the Church of Saint Berres, Parish of Llanferras, County of Denbigh; and in the old portion of the Churchyard, with the following exceptions, that is to say :—

In the undermentioned earthen graves now existing in the said portion of the Churchyard, the burial may be allowed of the bodies of the following persons at their decease, viz. :—

(1) Robert Edwards, of Pentre Carrig, in the said Parish, in the grave of his wife,

(2) John Hughes, of Maeshafn, in the said Parish, in the grave of his wife; subject in each case to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

Now, therefore, His Majesty in Council is pleased hereby to give notice of such Representation, and to order that the same be taken into consideration by a Committee of the Privy Council, on the 2nd day of November next.

And His Majesty is further pleased to direct that this Order be forthwith published in the *London Gazette*, and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the Parish affected by such Representations one month before the said 2nd day of November.
