GENERAL ORDER OF THE LOCAL GOVERNMENT BOARD.

REGULATIONS AS TO THE DIETARY OF CASUAL PAUPERS.

> To the Guardians of the Poor of the several Poor Law Unions for the time being in. England and Wales;—

To the Board of Management of the Metro politan Asylum District;---

And to all others whom it may concern.

WHEREAS, by the Orders mentioned in column 1 of Schedule A to this Order, We, the Local Government Board, made Regulations prescribing, amongst other things, the dietary of casual paupers;

And whereas it is expedient that other provision should be made as hereinafter mentioned with respect to the dietary of casual paupers:

NOW THEREFORE, We do hereby rescind, so much of the Orders mentioned in column 1 of Schedule A to this Order as is specified in column 2 of that Schedule, and We do further Order that the Regulations hereinafter contained shall, except so far as We otherwise Direct, apply and have effect throughout England and Wales:—

ARTICLE I.—In this Order, unless the contrary intention appears—

Words in the masculine include females, words in the singular include the plural, and, words in the plural include the singular; The expression "the Guardians" means a

The expression "the Guardians" means a Board of Guardians elected under the Poor Law Amendment Act, 1834, and the Acts amending the same, and includes a Board of Guardians or other body of persons performing under a Local Act the like functions to a Board of Guardians under the Poor Law Amendment Act, 1834, the Board of Management of the Metropolitan Asylum District, and a Joint Committee of two or more Boards of Guardians;

The expression " Poor Law Union " means.
