- 2. Regulation 6 of Schedule B to this Order shall apply in regard to the milk to be provided under the foregoing Regulation.
- 3. Where practicable the meal shall be provided at a way-station or place of call in pursuance of an arrangement with a Committee acting for the area of one or more Poor Law Unions.
- 4. If in any case the Master of the Workhouse or the Superintendent of the Casual Ward, as the case may be, does not provide a casual pauper with an order or other authority for obtaining a midday meal at a way-station or place of call, or with a midday meal, he shall enter a note of his reasons opposite to the name of the casual pauper in the Admission and Discharge Book required to be kept under Article 8 of the Order of the Local Government Board dated the 18th day of December, 1882.

DISTRICT AUDITOR: ASSIGNMENT OF DUTIES AND DISTRICT.

District Edmund Burd, То Pearse Auditor ;-

To the Authorities in England and Wales whose Accounts are subject to Audit by a District Auditor ;-

And to all others whom it may concern.

WHEREAS by section 4 of the District Auditors Act, 1879, it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act, and may from time to time change wholly or in part such Duties or Districts;

And whereas certain District Auditors either are serving or are about to serve in His Majesty's Forces during the present War, and it is necessary to provide during their absence for the Audit of Accounts in the Districts for which they ordinarily act;

And whereas Edmund Pearse Burd is a District Auditor duly appointed under the provisions of the Statutes in that behalf:

NOW THEREFORE, We, the Local Government Board, hereby certify the appointment to the office of District Auditor of the said Edmund Pearse Burd (hereinafter referred to as "the District Auditor"), and do Order and Prescribe as follows:-

ARTICLE I .- The District Auditor is hereby authorised to audit the Accounts of all or any

of the Authorities and their Officers whose Accounts are or may be by law subject to be audited by a District Auditor.

ARTICLE II .- The District Auditor shall audit the said Accounts according to the provisions of the several Statutes and of the Orders issued by competent authority in force for the time being in that behalf, and shall perform all such duties and exercise all such powers in connection with the audit of such Accounts as are prescribed and conferred by the said Statutes and Orders.

ARTICLE III.—The District Auditor is hereby authorised to act as Auditor for all or any of the Audit Districts in England and Wales.

ARTICLE IV.—This Order shall be in addition to, and not in substitution or derogation of, any Order in force assigning a District to another District Auditor for the discharge of his duties, or prescribing his duties.

ARTICLE V .- This Order shall come into operation on the date thereof.
