MOTOR CAR ACT, 1903.

BOROUGH OF WALLASEY.

Whereas by section 8 of the Motor Car Act, 1903 (hereinafter referred to as "the Act of 1903") it is enacted that the Local Government Board may by regulations made under section 6 of the Locomotives on Highways Act, 1896 (hereinafter referred to as "the Act of 1896") prohibit or restrict the driving of any motor cars or of any special kind of motor cars, on any specified highway or part of highway, which does not exceed sixteen feet in width, or on which ordinary motor car traffic would, in their opinion, be specially dangerous.

Notice is hereby given, that the Town Council of Wallasey have made application to the Local Government Board for a regulation to be made under section 6 of the Act of 1896 and section 8 of the Act of 1903 for restricting to 8 miles per hour the speed at which any motor car may be driven along the Marine Promenade to the North of Victoria Road, New Brighton, within the Borough.

Notice is hereby further given, that objections to the making of any such regulation may be sent in writing to the Local Government Board at their offices at Whitehall, London, S.W., on or before the fifth day of November, 1914.

A copy of such objection should be sent at the same time by the objector to the Town Clerk, Town Hall, Wallasey.
