Rochdale (Marland) Town Planning Scheme.

Notice is hereby given, in pursuance of subsection (4) of section 54 of the Housing, Town Planning, &c. The letter or representation shall indicate clearly the scheme to which the objection is taken, and shall state fully in what respects the person or authority objecting claims or claim to be interested in the scheme and the grounds on which the objection is made.
