thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Jude, Blackburn, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Jude, Blackburn.'

"And with the like consent of the said Edmund Arbuthnott, Bishop of Manchester, (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials, should be solemnized or performed at the said Church of Saint Jude, Blackburn, situate as aforesaid, and that the fees to be received in respect of the publication of such banns, and of the solemnization or performance of the said offices, should be paid and belong to the Minister of the same Church for the time being: Provided always, that, so long as the Reverend Frederick George Chevassut, Clerk in Holy Orders, the present Vicar or Incumbent of the Vicarage of the said New Parish of St. Thomas, Blackburn, shall continue to be such Vicar or Incumbent, all the fees which may be received in respect of such publication, solemnization, or performance at the said Church of Saint Jude, Blackburn, situate as aforesaid, shall be paid over by the Minister thereof to the said Frederick George Chevassut: and Provided also, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet."

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Jude, Blackburn, being: -All that part of the New Parish (sometime District Chapelry) of Saint Thomas, Blackburn, in the County of Lancaster, and in the Diocese of Manchester, which is bounded upon the south-east by the New Parish of Saint Oswald, Knuzden, upon the north-east by the New Parish of Saint Peter and Saint Paul, Rishton, upon the north by the District Chapelry of Saint Stephen, Blackburn, all in the said County and Diocese, and upon the remaining sides, that is to say, upon the west and upon the south, by an imaginary line commencing upon the boundary which divides the said District Chapelry of Saint Stephen, Blackburn, from the said New Parish of Saint Thomas, Blackburn, at the centre of the bridge which carries Harwood Street across the Leeds and Liverpool Canal, and extending thence first southward and then south-eastward along the middle of Harwood Street for a distance of twenty-five chains or thereabouts to its junction with the street called Furthergate, and extending thence eastward along the middle of Furthergate for a distance of four chains or thereabouts to its junction with Cherry Street, and extending thence first southward and then south-eastward along the middle of Cherry

Street for a distance of nineteen chains or thereabouts to its junction with the street called Audley Range, and extending thence northeastward along the middle of Audley Range for a distance of twenty chains or thereabouts to its junction with Delph Lane upon the boundary which divides the said New Parish of Saint Thomas; Blackburn, from the said New Parish of Saint Oswald, Knuzden."

And whereas the said Representation has been approved by His Majesty in Council.

NOW, THEREFORE, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Manchester.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the Consecrated Church of Saint Barnabas, Mossley Hill, situate in the New Parish (sometime Particular District) of Saint Matthew and Saint James, Mossley Hill, in the County of Lancaster, and in the Diocese of Liverpool.
