

Liverpool, (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said New Parish of Saint Matthew and Saint James, Mossley Hill, which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Barnabas, Mossley Hill, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Barnabas, Mossley Hill.'

"And with the like consent of the said Francis James, Bishop of Liverpool, (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials, should be solemnised or performed at the said Church of Saint Barnabas, Mossley Hill, situate as aforesaid, and that the fees to be received in respect of the publication of such banns, and of the solemnisation or performance of the said offices, should be paid and belong to the Minister of the same Church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Barnabas, Mossley Hill, being:—All that part of the New Parish (sometime Particular District) of Saint Matthew and Saint James, Mossley Hill, in the County of Lancaster, and in the Diocese of Liverpool, which is bounded upon the south-east by the New Parish of Allerton, upon the north-east partly by the last-named New Parish and partly by the New Parish of (the Holy Trinity) Wavertree, upon the north-west partly by the last-named New Parish and partly by the New Parish of Saint Bridget, Wavertree, all in the said County and Diocese, and upon the remaining sides, that is to say, upon the south-west and upon the south by an imaginary line commencing at the point where the boundary which divides the said New Parish of Saint Bridget, Wavertree, from the said New Parish of Saint Matthew and Saint James, Mossley Hill, meets the middle of Smithdown Road at a distance of one chain and a quarter or thereabouts from the junction of such road with Garmoyle Road, and extending thence eastward along the middle of Smithdown Road for a distance of three chains or thereabouts to the centre of the bridge which carries the Edge Hill and Garston Line of the London and North-Western Railway across such road, and extending thence south-eastward along the middle of the said line of rail-

way for a distance of forty-two chains or thereabouts to a point opposite to the middle of the road called Queen's Drive, and extending thence north-eastward to and along the middle of Queen's Drive for a distance of twelve chains and a half or thereabouts to its junction with Dovedale Road, and extending thence south-eastward along the middle of Dovedale Road and in a straight line in continuation thereof for a distance of twenty-four chains and a half or thereabouts to a point in the middle of Rose Lane upon the boundary which divides the said New Parish of Saint Matthew and Saint James, Mossley Hill, from the said New Parish of Allerton."

And whereas the said Representation has been approved by His Majesty in Council.

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Liverpool.

The KING has been pleased by Letters Patent under the Great Seal to present The Rev. William Edwards Parry, B.A., to the Vicarage of Stokenham with Chivelstone and Sherford, in the county of Devon and diocese of Exeter, void by the death of the last Incumbent and in His Majesty's Gift in full right.

In consequence of an outbreak of infectious disease among the inmates of the Liverpool Reformatory for Girls, 6, Mount Vernon Green, Liverpool, it has become necessary for certain of the inmates of the Reformatory to be removed to and temporarily housed at 16, Newsham-drive, Newsham Park, Liverpool, and the Secretary of State for the Home Department hereby gives notice, that he has certified that the said premises are fit to be part of the Liverpool Girls' Reformatory for the temporary accommodation—for six months from this date—of girls sent thereto in pursuance of the Children Act, 1908.

The Certificate bears date the 30th November, 1914, and provides that the total number of girls in the said Reformatory, including the premises at 16, Newsham-drive, whether sent thereto in pursuance of the said Act or otherwise, shall not at any one time exceed ninety.
