Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His MaMjesty in Council, a Representation, bearing date the 19th day of November, in the year 1914, in the

words and figures following, that is to say:—
"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint James, Guernsey, situate in the Parish of Saint Peter Port, in the Island

of Guernsey, and in the Diocese of Winchester.
"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint James, Guernsey,

situate as aforesaid.

"Now, therefore, with the consent of the Right Reverend Edward Stuart, Bishop of Winchester, (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said Parish of Saint Peter Port, which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint James, Guernsey, situate as aforesaid, and that the same should be named 'The District Chapelry

of Saint James, Guernsey.'
"And with the like consent of the said Edward Stuart, Bishop of Winchester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials, should be solemnized or performed at the said Church of Saint James, Guernsey, situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the Minister of the same Church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office

of baptism or for the registration thereof.
"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order with respect thereto as to Your Majesty in Your Royal Wisdom shall

seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint James, Guernsey, being:—All that part of the Parish of Saint Peter Port, in the Island of Guernsey, and in the Diocese of Winchester, which is bounded upon the east by the sea, upon the north-east by the New Parish of Saint John, Guernsey, upon part of the west by the New Parish of Saint Stephen, Guernsey, both in the said Island of Guernsey, and in the said Diocese of Winchester, and upon the remaining sides, that is to say, upon the remaining part of the west and upon the south by an imaginary line commencing upon the boundary which divides the said new Parish of Saint Stephen, Guernsey, from the said Parish of Saint Peter Port, at the junction of Brock Road with Doyle Road, and extending thence south-eastward along the middle of Doyle Road for a distance of fifteen chains or thereabouts to its junction with Grange Road, and extending thence eastward along the middle of Grange Road for a distance of fifteen chains and a quarter or thereabouts to its junction with Saumarez Street and Saint James Street, and extending thence north-eastward along the middle of Saint James Street for a distance of five chains and three-quarters or thereabouts to its junction with the street called the Rue Marguerite, otherwise New Street, and extending thence south-eastward along the middle of the Rue Marguerite for a distance of two chains and three-quarters or thereabouts to its junction with Le Febvre Street, and extending thence first eastward then northward and then again eastward along the middle of Le Febvre Street for a distance of seven chains and a half or thereabouts to its junction with High Street opposite to the Pier Steps, and extending thence south-eastward across High Street and along the middle of the Pier Steps for a distance of two chains or thereabouts to the eastern end of the said steps on the western side of The Quay, and extending thence eastward in a straight line parallel with the northern wall of the Old Harbour to the sea."

And whereas the said Representation has been approved by His Majesty in Council.

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Winchester.
