Postponement of date of operation of Act.

- To the Mayor, Aldermen, and Commons of the CITY OF LONDON, in Common Council assembled ;---
- To the Councils of the several Metropolitan Boroughs, Municipal Boroughs, and other Urban Districts in ENGLAND and WALES ;---
- To the Councils of the several Rural Districts in ENGLAND and WALES ;---

WHEREAS by sub-section (1) of Section 18 of the Milk and Dairies Act, 1914 (hereinafter referred to as "the Act") it is enacted that the Act shall come into operation on the 1st day of January, 1915, or such later date, not being later than the 1st day of October, 1915, as the Local Government Board may, by Order, appoint;

And whereas it is expedient that the coming into operation of the Act should be postponed:

NOW THEREFORE, We, the Local Government Board, in the exercise of the powers conferred upon Us in that behalf. Do, by this Order, Appoint and Direct as follows, that is to say:—

ARTICLE I.—We appoint the First day of October, one thousand nine hundred and fifteen, as the date on which the Act shall come into operation.

ARTICLE II.—This Order may be cited as "The Milk and Dairies (Postponement of operation of Act) Order, 1914."

And whereas it is proposed that a Provisional Order should be issued in compliance with the said application;
