(3) To make provision with respect to the application of any moneys received and the defraying of any expenses incurred by the Corporation under the proposed Order; and

(4) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, in force in the said Borough as may be necessary or desirable;

SCARBOROUGH.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Scarborough (hereinafter called the Corporation), being the Urban District Council for the said Borough, have made application to the Local Government Board for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, to partially repeal, alter or amend the Scarborough Corporation Act, 1900, so as—

(1) To empower the Corporation to borrow, with the sanction of the Local

Government Board, such sums as may from time to time be required for the purpose of the construction of the sea-water, swimming and other baths which are authorised by the said Act;

(2) To empower the Corporation to advance by way of loan to the Scarborough Harbour Commissioners, in addition to the sum of £20,000 which they are authorised by Section 65 of the said Act to lend to the Commissioners, such sums as the Local Government Board may from time to time sanction; and

(3) For the several purposes of the application or for purposes connected with, incidental to, or consequent on those purposes, to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said Borough, as may be necessary or desirable;
