WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 21st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 3rd day of December, in the year 1914, in the words and figures following, that is to say :---"We, the Ecclesiastical Commissioners for

England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called ' the said Benefice ') of Itchingfield, in the County of Sussex, and in the Diocese of Chichester.

Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Itchingfield is vested for an estate in fee simple, in possession, free from incumbrances, in Ernest Frederick de Rougemont of No. 45, Porchester Square, in the County of London, Esquire.

'And whereas the said Ernest Frederick de Rougemont is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Itchingfield, now vested in him as aforesaid, should be transferred to and be vested in the Right Reverend Charles John, now Bishop of Chichester, and his successors in the same Bishop-

rick. "And whereas the said Charles John, Bishop of Chichester, is willing to accept such transfer, and in token of such his willingness, and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited, or by some or one of them, is made necessary, he, the said Charles John, Bishop of Chichester, has executed this Scheme as hereinafter mentioned.

And whereas the transfer of the patronage of the said Benefice of Itchingfield, which is hereinbeforementioned, and hereinafter recommended and proposed, will, in our opinion, tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson,

so recommended and proposed to be transferred as aforesaid, arises or exists, that is to say in the Parish of Itchingfield.

"Now, therefore, with the consent of the said Ernést Frederick de Rougemont, (in testimony whereof he has signed and sealed this Scheme), and with the consent of the said Charles John, Bishop of Chichester, (in testimony whereof he has signed this Scheme, and sealed the same with his Episcopal Seal), We, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Itchingfield, now vested in him the said Ernest Frederick de Rougemont as aforesaid, shall be transferred to the said Charles John, Bishop of Chichester, and his successors in the same Bishoprick, and shall thereupon and thenceforth become and be absolutely vested in, and shall and may from time to time be exercised by, the said Charles John, Bishop of Chichester, and his successors in the same Bishoprick for ever. "And we further recommend and propose

that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council.

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Chichester.

HEREAS the Local Government Board, after giving to the Incumbent and the Churchwardens of the Parish of Althorpe with Keadby, in the County of Lincoln (Parts of Lindsey), ten days' previous notice of their intention in that behalf, have, under the provisions of the Burial Act, 1853, made a Representation to His Majesty in Council, to the effect that, for the protection of the public health, the opening of any new burial ground in the Civil Parish of Althorpe, save with the previous approval of the Local Government Board, should be prohibited, and that burials should be discontinued therein, as follows, viz.:

ALTHORPE .- Forthwith and entirely in the Church of Saint Oswald, in the Parish of Althorpe with Keadby, in the County of
