

Lincoln (Parts of Lindsey); and in the two Churchyards attached thereto, with the following exceptions, that is to say:—

(1) In the case of the Churchyard in which the said Church is situate the burial may be allowed of the body of the widow of the late William Gregory Harxley, at her decease, in the walled family grave now existing in such Churchyard, subject to the condition that the coffin containing the body be separately enclosed by stonework or brickwork properly cemented.

(2) (a) In the case of the Churchyard situate immediately to the north-west of the said Church, and abutting on the main street of the village of Althorpe, the burial may be allowed in the walled grave belonging or reputed to belong to James Stephenson, and in the two walled graves constructed in the years 1859 and 1866 respectively, and belonging or reputed to belong to John Thomas Brown, of the body of any member of the family of the person or persons heretofore buried in such graves, subject in each case to the condition that the coffin containing the body be separately enclosed by stonework or brickwork properly cemented; and

(b) In the last mentioned Churchyard the burial may be allowed of the bodies of George Middleton and Jane Middleton, at their decease, in a grave space in which no interment has heretofore taken place, and which has been reserved and appropriated as a burial place, with the exclusive right of burial therein, subject in each case to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

Now, therefore, His Majesty in Council is pleased hereby to give notice of such Representation, and to order that the same be taken into consideration by a Committee of the Privy Council, on the 18th day of February next.

And His Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the Parish affected by such Representation one month before the said 18th day of February.

Notice is hereby given, that a Petition of the Right Honourable Viscount Ridley, President, and others, Vice-Presidents and Members of Trinity College of Music, London, praying for the grant of a CHARTER OF INCORPORATION to the said College, has been presented to His Majesty in Council; and, His Majesty having referred the said Petition to a Committee of the Lords of the Council, notice is further given, that all petitions for or against such grant should be sent to the Privy Council Office on or before the 8th day of February next.

WHEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

AND WHEREAS it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section one of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

AND WHEREAS by a Proclamation, dated the 10th day of November, 1914, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section one of the Exportation of Arms Act, 1900, and Section one of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain Warlike Stores was prohibited:

AND WHEREAS by an Order of Council, dated the 5th day of December, 1914, the said Proclamation was varied and added to in certain particulars:

AND WHEREAS there was this day read at the Board a recommendation from the Board of Trade to the following effect:—

That the Proclamation, dated the 10th day of November, 1914, as varied and added to by the said Order of Council, dated the 5th day of December, 1914, should be amended by making the following additions to and alterations in the same:—

(1) That the prohibition of the carriage coastwise of "Animals, pack, saddle and draught, suitable for use in war" should be removed.

(2) That "Tea" should be deleted from the list of articles the exportation of which is prohibited to all foreign ports in Europe and on the Mediterranean and Black Seas other than those of France, Russia (except Baltic ports), Belgium, Spain, and Portugal.

(3) That "Cocoa" should be added to the list of articles the exportation of which is prohibited to all foreign ports in Europe and on the Mediterranean and Black Seas other than those of France, Russia (except Baltic ports), Belgium, Spain, and Portugal.

(4) That "Jewelled draw-plates for drawing steel wire" should be added to the list of articles the exportation of which is prohibited to all destinations abroad other than British possessions and protectorates.

Now, THEREFORE, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, and all other persons whom it may concern, are to take notice and govern themselves accordingly.
