ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 11th January, 1915.)

Whereas, by the 21st section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Subdistricts:—

- 1. And whereas it is expedient that Weedon Sub-district, of Daventry Registration District, should be abolished, and its constituent parishes added to the other sub-districts of the same registration district, as follows:—
 - (a) Brockhall, Dodford, Farthingstone, Floore, Stowe Nine Churches, and Weedon Beck Parishes to Long Buckby Sub-district; and
 - (b) Everdon, Fawsley, Newnham, and Preston Capes Parishes, together with the land (part of) common to Badby and Newnham Parishes, to Daventry Subdistrict, in which the other part of that common land is situated.
- 2. Now, therefore, I, Bernard Mallet, C.B., Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers given me by the above-mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect accordingly.
