Land Transfer Acts, 1875 and 1897.

NOTICE.—The following Persons are about to be registered as Proprietors of the following Properties with Absolute or Good Leasehold Title:—

Any person may, by notice in writing signed by himself or his Solicitor, and delivered at the Registry before the expiration of one month from the appearance of this notice, object to the registration. The notice must state concisely the grounds of the objection and give the address in the United Kingdom of the person delivering the notice, and if it is delivered by a Solicitor, must give the name and address of the person on whose behalf it is given.
