

XII. That the Warrants under the hand of His late Majesty King George the Third dated the 3rd December, 1783, the 24th February, 1785, and the 30th September, 1789, respectively, shall be and are hereby cancelled and made void and of no effect.

XIII. That nothing in this Our Warrant shall be deemed to abolish or derogate from the jurisdiction, authority and rights of Our Earl Marshal and Hereditary Marshal of England, or of Our Kings of Arms, save in so far as the

same may be effected by the cancelling of the aforesaid Warrants of the 3rd December, 1783, the 24th February, 1785, and the 30th September, 1789.

Given at Our Court at *Saint James's*, the eighth day *February*, one thousand nine hundred and ten, in the tenth year of Our Reign.

During the past year Sir John Arthur Owen, whose claim to a Baronetcy was not established when the Roll was first issued, produced further evidence in support of it, and his name has accordingly been placed on the Roll (No. 621).

On the 16th of July, 1914, His Majesty the King, on the advice of the Committee of the Privy Council, after a formal hearing, approved of the entry of the name of Major Sir James Bruce Wilkie Dalyell on the Roll of the Baronetage in respect of the Baronetcy of Dalyell of Binns.

Since the 1st December, 1913, fourteen new Baronetcies have been created and the following Baronetcies have become extinct:—
