roadway running past the western ends of Gwent Street, Bryn-gwyn Place, and Coedcae Terrace and also past the north-western side of the premises attached to the houses known as Ivy Cottage and Sycamore House into Albion Road, and extending thence first south-ward, and then in various directions along the middle of such roadway for a distance of fourteen chains and a half or thereabouts to its junction with Albion Road, and extending thence south-westward along the middle of Albion Road and of the road in continuation thereof for a distance in all of twenty-one chains or thereabouts to the point beyond the bridge or culvert carrying the lastmentioned road across Trosnant Brook where such road crosses the boundary which divides the said Parish of Trevethin from the said

Parish of Panteg.
"II. And also all that contiguous portion of the said Parish of Panteg which is bounded upon all sides as follows, that is to say upon the west by the Parish of Mynyddislwyn, in the said County and Diocese, upon the north-west and upon the north by the said Parish of Trevethin, upon the north-east by the portion of the Civil Parish of Llanvihangel Pontymoil which is included in the said Parish of Panteg, upon part of the south by the Consolidated Chapelry of Saint Hilda, Griffithstown, in the said County and Diocese, and upon the remaining part of the south by an imaginary line commencing at the point near the north-western corner of the said Consolidated Chapelry of Saint Hilda, Griffithstown, where the boundary which divides such Consolidated Chapelry from the said Parish of Panteg meets the fence which divides the close numbered 214 upon the Ordnance Survey Map of the Parish of Panteg published in the year 1882 upon the scale of 25 inches to a mile, and also upon the map or plan annexed to this Representation, from the close numbered 174 upon the said maps, and extending thence westward along the said fence for a distance of three chains or thereabouts to the point where such fence meets the eastern side of the road leading from Pontymoil to Penyrheol, and extending thence southward along the fences which divide the said close numbered 214 and the closes numbered 254, 256, and 257 upon the said maps from the said road and from the closes numbered 253, 252, and 250 upon the said maps for a distance of twenty-seven chains or thereabouts to the point where the fence dividing the said close numbered 257 from the said close numbered 250 meets the northern side of the road leading from the above-mentioned road to New Farm, and extending thence southward across the said road leading to New Farm for a distance of ten yards or thereabouts to the point where the fence on the southern side of such road meets the fence which divides the close numbered 425 upon the said maps from the close numbered 248 upon the same maps, and extending thence first southward, and then generally westward, along the fences which divide the said close numbered 425 and the closes numbered 424, 423, 422, 421, 462, 460, 452 and 439 upon the said maps from the said close numbered 248 and the closes numbered 416, 417, 418, 420, 419 and 406 upon the said maps for a distance of thirty-seven chains or thereabouts to the south-western corner of the said close numbered 406 which includes the house and premises known as the Oddfellows'

Arms, and extending thence in a straight line due west (thereby crossing Cwm Lickey, Twyn Calch, and Buarth Maen) for a distance of one mile and three quarters or thereabouts to the boundary which divides the said Parish of Panteg from the said Parish of Mynyddislwyn."

And whereas the said Representation has been approved by His Majesty in Council.

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar

of the said Diocese of Llandaff.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 8th and 9th years of Her late Majesty Queen Victoria, Chapter 70, of the Act of the 14th and 15th years of Her said late Majesty, Chapter 97, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 17th day of December, in the year 1914, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 8th and 9th years of Her late Majesty Queen Victoria, Chapter 70, of the Act of the 14th and 15th years of Her said late Majesty, Chapter 97, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a Consolidated Chapelry to the Consecrated Church of Saint Birinus, Morgan's Vale, situate within the Parish of Downton, in the County of Wilts, and in the Diocese of Salisbury.

"Whereas at certain extremities of the said Parish of Downton, and of the New Parish (sometime District Chapelry) of Saint Mary, Redlynch, in the said County and Diocese, which said extremities lie contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several Churches of such Parish and New

Parish respectively.

"And whereas it appears to us to be expedient that certain contiguous portions being the portions containing the population aforesaid) of the said Parish of Downton, and of the said New Parish of Saint Mary, Redlynch, should be formed into a Consolidated Chapelry for all ecclesiastical purposes, and that the same should be assigned to the said
