Church of Saint Birinus, Morgan's Vale, situate as aforesaid.

"Now, therefore, with the consent of the Right Reverend Frederic Edward, Bishop of Salisbury, as such Bishop, (in testimony whereof he has signed and sealed this Representa-tion), with the consent of the Warden and Scholars, Clerks of Saint Mary's College of Winchester, in the County of Southampton, as the Patrons of the Vicarage of the said Parish of Downton (in testimony whereof they have caused their Common or Collegiate Seal to be affixed to this Representation), and with the consent of the Reverend Lenthall Greville Dickenson, Vicar or Incumbent of the said Vicarage of the Parish of Downton, and, as such Vicar or Incumbent, the Patron of the Vicarage of the said New Parish of Saint Mary, Redlynch, (in testimony whereof he has signed and sealed this Representation), we, the said Ecclesiastical Commissioners for England, humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said Parish of Downton, and of the said New Parish of Saint Mary, Redlynch, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one Consolidated Chapelry for the said Church of Saint Birinus, Morgan's Vale, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Birinus, Morgan's Vale.'

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal Wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Birinus, Morgan's Vale, comprising:—

"I. All that portion of the Parish of Downton, in the County of Wilts, and in the Diocese of Salisbury, which is bounded upon the east by the New Parish (sometime District Chapelry) of Saint Mary, Redlynch, in the said County and Diocese, upon the south by the Parish of North Charford, in the County of Southampton, and in the Diocese of Winchester, and upon the remaining sides, that is to say, upon the west and upon the north, by an imaginary line commencing at the point where the boundary which divides the said Parish of North Charford from the said Parish of Downton crosses the middle of the roadway leading from Searchfield Farm into the main road between Woodfalls and North Charford, and extending thence north-eastward along the middle of the said roadway for a distance of twelve yards or thereabouts to its junction with the roadway leading from Lodge Farm into the said main road, and extending thence north-westward along the middle of the last-mentioned roadway for a distance of six chains and a half or thereabouts to a point opposite to the southern end of the fence which divides the Close numbered 40 upon the Ordnance Survey Map of the Civil Parish of Downton published in the year 1901 upon the scale of 25 inches to a mile, and also

upon the map or plan which is annexed to this Representation, from the Close numbered 37 upon the said maps, and extending thence first northward to the said fence, and then first northward and then in various directions along. the fences which divide the said Close numbered. 40 and the Closes numbered 41, 42, and 75 upon the said maps from the said Close numbered 37 and the Closes numbered 36, 35, 43 and 34 upon the said maps for a distance of thirty-one chains and a half, or thereabouts, to the point where the fence which divides the said Close numbered 75 from the said Close numbered 34 meets the southern side of the road leading from Woodfalls into Slab Lane, and extending thence first northward to, and then first north-westward and then northward along, the middle of the last-mentioned road for a distance of thirty-one chains or thereabouts to its junction with Slab Lane, and extending thence north-westward along the middle of Slab Lane for a distance of sixteen chains or thereabouts to a point opposite to the southern end of the fence which divides the Close numbered 176 upon the said maps from the Close numbered 135 upon the said maps, and extending thence first northward to such fence, and then first northward and then in various directions along the fences which divide the said Close numbered 176 and the Close numbered 174 upon the said maps from the said Close numbered 135 and the Close numbered 173 upon the said maps for a distance of twenty-seven chains or thereabouts to the point where the fence which divides the said Close numbered 174 from the said Close numbered 173 meets the southern side of the road leading from Downton to Redlynch, and extending thence first northward to and then eastward along the middle of such road for a distance of twelve chains and a half or thereabouts to its junction opposite to the house and premises known as Paccombe Farm with the roadway leading to the Close numbered 248 upon the said maps, and extending thence northward along the middle of such roadway for a distance of twenty-one chains or thereabouts to the fence forming the southern boundary of the said Close numbered 248, and extending thence eastward along the last-mentioned fence which divides the said Close numbered 248 from the last-mentioned roadway and from the Closes numbered 225, 223 and 221 upon the said maps for a distance of thirty chains and a half or thereabouts to the point where such fence meets the western side of Salt Lane, and extending thence eastward in a straight line toa point in the middle of Salt Lane upon the boundary which divides the said Parish of Downton from the said New Parish of Saint Mary, Redlynch.

"II. And also all that contiguous portion of the said New Parish of Saint Mary, Redlynch, which is bounded upon the south-west and upon the west by the above described portion of the said Parish of Downton, and upon the remaining sides, that is to say, upon the north, upon the north-east, and upon the south, by an imaginary line commencing upon the boundary which divides the said Parish of Downton from the said New Parish of Saint Mary, Redlynch, at the junction of Salt Lane with the road leading along the northern and north-eastern sides of the grounds attached to Redlynch House, and extending thence first eastward and then south-eastward along the
